WHEN SHOULD I FILE A CLAIM?

Homeowners insurance policies generally require policyholders to file claims quickly. Be sure to file yours as soon as possible – in as much detail as you can – to avoid missing deadlines.

WHAT DAMAGES ARE AVAILABLE?

If you were affected by a wildfire, you may be entitled to damages including:

- Property damage
- Past and future medical expenses (e.g., hospitalization, therapy, medication)
- Pain and suffering
- Loss of life's enjoyment
- Funeral expenses (in the event of a loved one's passing)
- · Other applicable damages

WHAT WILL THE INSURANCE COMPANY DO TO AVOID PAYING?

Insurance companies are primarily concerned with their bottom line, so they benefit from paying you as little as possible. To that end, they might:

- Deny or delay your claim without reason
- Undervalue your claim
- · Ignore or refuse to investigate your claim
- Neglect to process your claim
- Fail to communicate with you
- Misrepresent the language in your policy
- Ask that you contribute to the settlement
- Make unreasonable demands regarding proof of loss

DO I STILL HAVE TO PAY MY MORTGAGE IF MY HOME BURNED DOWN?

Generally, yes. However, some lenders may offer a grace period in which they won't penalize you for late payments. Contact your lender to find out what their disaster relief policies entail.

WHAT ABOUT MY UTILITIES?

If your home burned down, you'll need to contact your utility providers to find out what disaster relief they provide, if any.

IS MY BUSINESS INCOME COVERED?

Most policies will cover some loss of business income if a natural disaster occurs. However, insurance companies often challenge legitimate claims, so it's important to hire a lawyer to protect your rights.

HOW DO WILDFIRES START?

Wildfires can occur naturally, but most are the result of <u>human error</u>. A spark can ignite an inferno in the presence of brush, dry grass, and trees. Thick vegetation and overgrown forests are prime areas where blazes spread out of control. Wildfires tend to occur during droughts and times of extreme heat.

WHAT ARE THE POTENTIAL HEALTH EFFECTS OF INHALING SMOKE?

Exposure to wildfire smoke can cause immediate symptoms such as coughing, wheezing, difficulty breathing, itchy or burning eyes, and runny nose. If you have a pre-existing heart or lung condition, these symptoms may be more severe.

Although the long-term effects are not well-understood, it's known that wildfire smoke is more toxic than other types of smoke. Exposure can increase your risk for respiratory disease, stroke, and other serious health complications.



Dangers of Wildfires: Key Statistics

Wildfires are becoming more destructive. In the 1980s and 1990s, the average wildfire burned between 40 and 80 acres – the 2010s, however, saw several years where the average exceeded 100 acres.

According to the National Interagency Fire Center (NIFC), blazes in the 2010s burned <u>6.8 million acres</u> annually, more than double that of two decades prior (3.3 million). The number of annual wildfires has slightly decreased over the last 30 years, while the number of acres burned each year has increased.

Also according to the NIFC, the largest fire season on record was in 2015, when 10.1 million acres burned — more than half of which were in Alaska. In 2020, more than 44,000 wildfires had destroyed almost 7.7 million acres by October 1st.

According to the U.S. Fire Administration (USFA),

California, Texas, and New York had the most fire deaths in the country in 2017. In terms of population, West Virginia, Alaska, and Arkansas had the most deaths per million that year.



Out of all types of properties, residential properties see the most deaths and injuries, as well as the greatest dollar loss from fire, according to the USFA.

From January 1, 2020 through October 25, 2020, CAL FIRE responded to <u>7,221 fires</u> which burned 1,465,048 acres. In the same timeframe in 2019, 4,964 fires burned 131,137 acres in California.

According to the <u>U.S. Department of Agriculture</u>, today's fire seasons are 78 days longer than they were in the 1970s. Almost a dozen states have had their largest fires on record after the year 2000.

California and Texas <u>ranked in the top five</u> for both number of fires and acres burned in the U.S. in 2019. These two states were also the top two in estimated number of properties at risk in the same year.

The U.S. lost <u>8,534,580</u> acres to wildfire between January 1st and October 29th 2020, which was up from 4,558,859 acres over the same span in 2019.





What Should I Do After a Wildfire?

If you've been injured, lost a loved one, or sustained property damage in a wildfire, it's important that you take certain steps to bolster your claim.

- **1. Take inventory of your losses:** It's a painful process, but it's vital that you make note of all of the items you lost in the fire. This includes everything from cars and appliances to family heirlooms and photographs. Any property that was damaged or destroyed should be accounted for.
- **2. Document everything:** If you were injured, keep track of your medical bills. If you spoke with the insurance company, take notes of what was said. By documenting everything, you improve your chances of recovering all of your losses.



Restoring Basketball Glory

In 2018, the NCAA imposed a penalty on the men's basketball team at the University of Louisville (Kentucky) for alleged rules violations. They had their 2013 NCAA tournament win, 2012 Final Four appearance, and individual player statistics vacated and removed from the record.

With the help of John Morgan, our firm's founder, the team's players sued the NCAA and last year reached a confidential settlement. The players had all their statistical achievements and personal honors restored.

Major Settlement in MA Gas Explosions Case

In September 2018, a series of explosions ripped through the Merrimack Valley, Massachusetts, towns of Lawrence, Andover, and North Andover. These explosions were caused by excess gas pressure in poorly built, poorly installed, and poorly maintained natural gas lines owned and operated by Columbia Gas of Massachusetts.

More than 40 homes experienced explosions and fires as a result, which caused severe damage and injury, including one death.

Morgan & Morgan's Frank Petosa took the lead in the lawsuit representing the victims, and in July 2019, a \$143 million settlement was reached.

Coverage appeared in The Washington Post and The Boston Globe, and was provided by the Associated Press.
